3. Introduction

Breedon Parish Hall does not have a licence to sell alcohol. Therefore, for all functions there are 3 options to legally consume alcohol whilst on the premises:

4. Options

Option 1

Bring your own alcohol for your own consumption – this is the simplest method to consume alcohol at all functions. It is the cheapest and guarantees that you drink what you like best. Under no circumstances should that alcohol be sold to other persons whilst on the premises. At the end of the function you are required to take all ‘empties’ with you – there are no facilities to leave them at Breedon Parish Hall. Recycling bin bags will be available for you to use and take away with you for disposal. Failure to comply with this may result in forfeiture in part, or full, of your deposit.

Option 2

If you are organising a function you may, at your own expense, pay for an appropriately licenced company to sell and serve alcohol whilst in the Parish Hall. Evidence of the company having a licence to sell alcohol must be produced at the time of booking. The company, or hirer, is responsible for taking away all ‘empties’ and waste. Failure to comply with this condition may result in loss of part, or full, deposit.

Option 3

The committee may apply for a Temporary Event Notice (TEN) to sell alcohol. Specific details will have to be given to the authority granting the TEN and up to 20 TENs may be applied for each year. A TEN must be in an individual’s name. For more information see the following link: www.gov.uk/temporary-events-notice

5. Notes

- No alcohol is to be consumed in the Parish Hall car park, the entrance drive or the immediate areas surrounding the Parish Hall
- For outside functions, where activities are planned on the main Green or the green area by the line of Memorial trees, then alcohol may be consumed there, providing that is the conditions of the hire agreement for that specific event
- Under no circumstances whatsoever, is alcohol permitted to be consumed in any of the road or pavement areas by the Parish Hall
- It is the hirer’s responsibility to ensure that no one under 18 consumes alcohol.
