

Bremhill View - Terms and Conditions
Hirers

The following Terms and Conditions of Contract are between the Hirer named below and Calne Town Football Club.

1. The part of the building hired may only be used for the purpose for which it was originally booked.
2. The Hirer is deemed to be held responsible for the conduct of all persons attending the venue and is liable for any form of damage caused during the period of hire.
3. Full payment of the Venue Only Hire Fee is required 28 working days prior to the function.
4. A holding deposit of £50 is required 28 working days prior to the function and will be returned via bacs after satisfactory inspection of the venue.
5. The room hire deposit is not refundable.
6. All cancellations must be made in writing and sent by recorded delivery. Your cancellation will be acknowledged in writing and sent by recorded delivery.
7. In the event of cancellation, the following charges will apply:
 - two to four months prior to the function – 30% of the estimated account
 - two weeks to two months prior to the function – 60% of the estimated account
 - less than 14 days' notice – the full charge will apply
8. No contractual liability for a booking has been accepted until confirmation has been issued by Calne Town Football Club to confirm acceptance of the reservation.
9. The venue must be returned in a hygienic manner with all surfaces wiped down and rubbish in tied bags.
10. The Hirer is to ensure that at all times fire and safety regulations are adhered to.
11. No items may be adhered in any fashion to wall or door surfaces.
12. The Hirer shall indemnify Calne Town Football Club against death, injury, damage, loss or any claim arising from hire of the premises.
13. Calne Town Football Club will not accept responsibility for any loss or damage to vehicles using the car park, nor for items left in the cloakroom.

14. The sale of tickets at the door is not permitted.
15. Calne Town Football Club reserves the right to cancel a contract with any group or individual where written or other material produced or displayed by that group in connection with the contract brings or is likely to bring Calne Town Football Club into disrepute.
16. No pyrotechnics or smoke machines are to be used by disco operators or others.
17. DJs and entertainers are required to have documented evidence that all equipment is PAT tested and certified electrically safe.
18. Additional electrical installations are not normally permitted and if required 21 days' notice must be given. All equipment to have documented evidence that it is PAT tested and certified electrically safe.
19. The premises are subject to the Statutory and Licensing Regulations including those relating to fire precautions and entertainment.

IMPORTANT INFORMATION

Regular Hire Fees are only applicable to Calne Town Football Club based groups and organisations. These fees are applicable only when the venue is booked and used during normal operating hours of 9am till 5:30pm and where a room is available. Where a commercial booking is required for the same room an alternative room may be provided or a cancellation given if at least 1 month in advance.

This will not occur on more than 2 consecutive Regular Hirer Bookings. Please ask for clarification before signing
