Hirers Privacy Notice

When you hire the Centre or hold an event on the Football Field / Playing Field, the information you provide (personal information such as name, address, email address, phone number) will be processed and stored so that it is possible to contact you and respond to your correspondence, provide information, send invoices and receipts relating to your hire agreement. Your personal information will not be shared with any third party without your prior consent.

When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

Our Right to Process Information

General Data Protection Regulations Article 6 (1) (a) (b) and (e)

Processing is with consent of the data subject or

Processing is necessary for compliance with a legal obligation or

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

Information Security

Waddesdon Parish Council has a duty to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted. (You may request the deletion of your data held by Waddesdon Parish Council at any time).

Access to Information

You have the right to request access to the information we have on you. You can do this by contacting the Clerk to the Parish Council clerk@waddesdonparishcouncil.gov.uk

Information Correction

If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate. Please contact the Clerk to the Parish Council clerk@waddesdonparishcouncil.gov.uk to request this.

Information Deletion

If you wish Waddesdon Parish Council to delete the information about you please contact the Clerk to the Parish Council clerk@waddesdonparishcouncil.gov.uk to request this.

Right to Object

If you believe that your data is not being processed for the purpose it has been collected for, you may object. Please contact the Clerk to the Parish Council clerk@waddesdonparishcouncil.gov.uk to object.

Rights Related to Automated Decision Making and Profiling

Waddesdon Parish Council does not use any form of automated decision making or the profiling of individual personal data.

Complaints

Summary

In accordance with the law, Waddesdon Parish Council only collect a limited amount of information about you that is necessary for correspondence, information and service provision. Waddesdon Parish Council does not use profiling, we do not sell or pass your data to third parties. Waddesdon Parish Council does not use your data for purposes other than those specified. Waddesdon Parish Council makes sure your data is stored securely. Waddesdon Parish Council deletes all information deemed to be no longer necessary.
